7:05 PM Director of Development update

- Acquisition of 8443 Dayton Pike
 - \circ $\;$ Attorney has to approve the survey to ensure our best interests are protected $\;$
 - There are many easements
 - The middle pit where stone mining was occurring has been filled in. It will be sprayed with seed that will establish quickly. We estimate we will have a sports field by May.
- Cafeteria has been finished
 - o It has a kitchen area
- Portable classroom space across the street
 - o High school will use 2 portables next year
 - They are almost done being manufactured delivery date is May 7
 - \circ $\;$ Need to settle the property so portables can be installed
 - Contractor bids are out

7:15 PM Executive Director update

- Amendment to the resolution for the USDA application
 - Already approved a \$700k loan for cafeteria building from First Horizon and switch to USDA, \$400k for the additional land purchase and absorb \$1.4 million for career center, and additional \$400k to finish cafeteria kitchen.
 - Need a new resolution to approve \$2.9 million instead of \$2.5 million to finish the kitchen.
 - \circ Will likely get grants to pay for some of the items in the loan.
 - Meece moved to increase the USDA loan from \$2.5 million to \$2.9 million. Skates seconded the motion, motion passed.
- Ivy Academy High school graduation is May 19 at 6:30 PM.
- USDA application updates
 - Application is very long and there are a lot of hoops to jump through (e.g. finding a surveyor) that require quick action.
 - May require electronic votes due to the time sensitive nature of the process.
- Staff requests for personal days during blackout days
 - Teachers receive sick days and personal leave days each year. They are not allowed to take them during blackout days like teacher development days. If they must take them off, they require board approval, or they have to take them unpaid.
 - Nikki Bender requested May 23rd son's school is having an end of year parade for the 5th graders. May 23rd is blocked off because too many teachers would request this time off since it's the last week of school. Patti Skates moved to approve, Meece seconded, motion passed.
 - Allison Klonne (High School Geometry teacher) requested taking time off during the testing window (Thursday, April 27 – Friday, April 28) to attend an alumni event at her alma mater in Ohio. Geometry tests will not take place on Thursday or Friday. Enicks moved to approve her taking both days off, Henderson seconded. Motion passed.

7:35 PM Internal Affairs update

- Current financial state
 - Have been going through new TISA funding model
 - This creates anxiety for charter schools, especially those on a growth model like Skillern, because TISA does not pay for growth – they pay based on previous year
 - Ivy Academy leadership staff was concerned that the school would receive a lot less funding than they have historically been granted.
 - Every class is weighted based on the jobs that are in demand for our area (agribusiness, HVAC, etc. are high demand jobs that would be rated higher than lower demand careers)
 - No way to estimate how much money the school will get for CTE
 - Holly went through an exercise of planning for receiving less funding (e.g. budget cuts).
 - Just learned that we will receive more funding next year than we did this year, so the conservative plan will no longer be needed.
 - Holly will need to readjust budget plans for next year with this new information.

7:50 PM Revision to bylaws

- Dr. Meece made a motion to add the following as a point D to section 2.3 of the lvy Academy bylaws: "The rules contained in the current edition of *Robert's Rules of Order Newly Revised* shall govern the Board in all cases to which they are applicable and in which they are not inconsistent with the bylaws of the Board and these standing rules."
- Skates seconded the motion. The motion carried.

 - Holly Slater to request estimated monthly payments for \$2.5 million vs. \$2.9 million from USDA loan officer and share with the board.
