6:25 - Financial Report P & L per year end - Dillon McGregor

- \$170,976.00 not including payroll
- Payroll will be \$120-130K
 - Net income 40-41 Thousand
- We are getting \$20K True up check, due to increased tax revenue
- Will put us at 60K in the bank
- Need more space
 - Alison is going to ask H&K about a discounted rate
 - They designed current building, have expressed interest in designing the next building
 - Could we ask Antidote for a discounted rate too (Sally works there)
 - If we cannot get it for free...we need to bid it out, anything over \$5k needs to be bid out
 - Let Sally help with the (Teal offered her Sally's service)
 - Cantus works for HeadStart may be able to get workers willing to do work for free.
 - Sequatchie concrete has offered to donate the concrete for next building (cannot donate labor)
 - Looking at 2 story steel building with energy efficient spray insulation
 - Need to steer contractors to our lean budget, we are not a government money gravy train
 - Growth plan has building complete for Fall 2019, it is POSSIBLE that we could complete for 2018.
 - We are 207-8 students for the year (max capacity for fire zone is 250)
 - P & C has offered to help, they may be willing to manage the project
