Executive Report:

Enrollment for next school year population by grade level. Need 10 more 9th graders for next year. Want 60. Lottery has been run.

Need a few more 7th. Going from 40-60 so we need 10 more.

6th and 8th grades are packed. Count on loss of about 5 per year. Going from 2 - 8th grade classes to 3 - 9th classes opens some spaces for freshmen.

Doing recruitment, going to boys and girls clubs and opportunity zone schools. May consider going to libraries. Have recruitment meetings on fridays. Magnet lotteries done so now kids may be on waiting lists for magnet schools, so we might appeal to those students.

Meece concerned about separate but equal. We reach out to lower socioeconomic but going from urban to rural...

Also working on welcome packet in Spanish.

Lost title I status two years ago. It comes with money, but also lots of reporting. So good and bad. Free and reduced still over fifty percent, but not direct served which is food stamps, assistance, etc.

Inner city kids more likely to be direct serve.

Environmental Institute signing day went very well. Got hat. Got certificates. Tn parks rep here for ceremony. Kids very excited.

Partnership progress with TN State Parks we get to use their logo for our work with parks. Helping with middle schools too. Jr Ranger program for MS. SO this is a HUGE DEAL. New Building Progress: Angie Markum says everything is on track to reach target date in august. No penalties until October. And we can use outdoors facilities in the fall if needed. There is a plan for the first few weeks of next year in case building is not done. Just hoping not to lose any students over it.
